Australian Society of Orthodontists Foundation for Research and Education POSTER AWARDS

INFORMATION FOR ENTRANTS

The poster presentations are intended to promote and foster the development of orthodontic research, education and practice.

- Posters should be presented in a Portrait View, approximately 900 mm wide by 1500mm high.
- Posters cannot be presented unless at least one author is registered for the meeting.
- A presenter can present up to 3 posters. If a presenter is presenting posters for a
 University or Dental School dealing with research undertaken during the training of
 orthodontists they can present up to 5 posters.
- Presenters are responsible for the hanging of their posters and must follow any directions about hanging given by the organisers.
- The presenter warrants that he/she, or their university or research body, is the sole owner
 or has the rights of all the information and content of the poster. The poster does not
 infringe any third party rights including Intellectual Property rights. If not, full disclosure of
 content ownership must be made. A poster which infringes intellectual property rights may
 not be accepted.
- The presenter, if they have a financial interest in the material presented, should clearly indicate this on the poster.
- A poster which is too advertorial or commercial in its content will not be accepted.
- The presenter must be present with their poster at the poster viewing time in the program, if applicable, to answer any questions related to their poster.
- The organisers have the right to remove any poster that does not comply with the conditions or spirit of the conditions outlined in these guidelines.

Applicants for the Poster Awards from 2017 are required to provide an abstract by email to annu.nangia@asofre.org.au before placing the Poster for assessment. Publishing of any of the abstracts on asofre.org.au or in the Australian Orthodontic Journal will be at the discretion of the ASOFRE committee and the Editor of AOJ.

Guidelines for the abstract are as advised for the AOJ (Guidelines to contributors). The abstract should be short, informative and be able to stand alone. It should convey the essence of the study. The following subtitles should be used in the abstract: background/objectives/aims, methods (e.g. briefly describe the setting, subjects, intervention, outcome measures), results and conclusions. Clinical relevance of a study may be mentioned in the conclusions.

- The ASOFRE committee shall determine the general conditions and manner of submission for the award.
- Research and clinical presentations are eligible for the award, while posters dealing with practice management, marketing or promotion of a particular product are not usually considered for the award.
- Posters will be judged in the same way that a paper in a peer reviewed journal is assessed. Poster layout using a structured format containing an introduction, aims and objectives, methodology, results and conclusion is encouraged.
- Posters to be included in the assessment for the 'Student Poster Award' must clearly state
 that the poster has been prepared by a current student, or one graduated less than 12
 months, and from which institution.
- The ASOFRE committee shall appoint assessors and prescribe the criteria for assessing posters. Acting on their advice the ASOFRE Committee may or may not elect to award a prize.
- The decision of the ASOFRE Committee is final and entrants have no right of access to assessor's reports or the ASOFRE's Committee deliberations.
